Minutes confirmed with the correction made.

PD noted that correction in relation to Lagotto Romagnolo and Coton de Tulear will be advertised in the March Dog World i.e. correcting February edition and stressed importance of EC checking the draft minutes immediately. To assist this process the draft minutes will be both uploaded to EC section of website and sent by email.

2. IMPORTANT ITEMS

NATIONAL EVENTS DATES

As had been advertised in the Dog World the dates were placed on the February 18/19 agenda for further consideration. An Obedience perspective was reported upon following their meeting of 11/12 February. In the first instance it was determined that the 2018-2020 NDOA's be held at Easter – 2018 in ChCh (RDA building), 2019 in Auckland (Ardmore) and 2020 in Taupo (new Events Centre with NZKC/Porirua as back-up). A move to Easter eliminates Manfield in Fielding as a venue. The move to Easter will be reviewed after 2020. Consideration need be given (date and/or venue) to the current AKC show (and 2 supporting shows) held at Easter at Ardmore in relation to 2019. Colleen Begg to investigate with priority being the parties working together. This was noted as unlikely with the barrier being car-parking. Options are alternative venue or date. Latter will suit AKC if a date can be found.

The Obedience committee had also discussed all three Nationals being held together as this was one option to be considered. They do not support this on an annual basis as venues/number of locations would be very limited and currently all events are being run around the country with a subsequent spread of workload. However, there was support if the concept was run as a celebration e.g. 10th or 25th anniversary. It was agreed by Executive Council (EC) that they supported the Obedience view with a discussion to be held at the joint EC, Agility & Obedience committee meeting being held on the Sunday of ACOD weekend. It was also agreed to table the idea of other discipline involvement at each of the National Events in an effort to attract more public and therefore a greater awareness of NZKC activities.

Finally, the Obedience committee signalled a preference to stage a joint event (4th) to showcase all disciplines and this will also be discussed at the joint meeting.

2019 events (Sunday 19th)

Recommendation that the 2019 NDS be held, as originally scheduled, in October school holidays.

Moved ST; Seconded KM - passed

It was agreed that an update can be noted at ACOD (President's report in Yearbook as seed) and that a survey be sent to all individual members later in 2017 looking at all options.

2016 NDS review

NT tabled a number of points for discussion as did the NZKC Treasurer. A copy of the office Guidelines was also provided with all points/discussion items targeted at the improvement of the NDS moving forward. The Guidelines will be subsequently updated. PD reiterated that the office provides secretarial support to the Show Secretary who should be appointed by the NDS committee. It was agreed that the Show Secretary must be part of the organising committee from start to finish. Standard of dress for judges was noted.

Two ideas worth noting for possible consideration in the future 1) Prelude held after NDS i.e. Sunday/NDS then on Thursday, Friday & Saturday. 2) There be pre-judging of Best in Show to make it the highlight and therefore more appealing to the public (and dignitaries).

Financial results

As requested at the November meeting GS provided BW with a full set of draft accounts and invoices to ensure income and expenditure were coded correctly i.e. where changes should be made to original instructions. GS & BW met separately to finalise the overall results pertaining to the NDS and the Prelude. GS to update the accounts to reflect the changes and provide a list of charges as invoiced to member clubs. It was agreed that where BW had identified under-charging from the original instructions an updated invoice would be sent to the clubs.

RISK REGISTER (RR)

RR is currently placed in February and July EC papers for review. In future it will first be reviewed by PD & GS then sent to A&R before placement in the papers (with any suggested amendments). This will be undertaken for April meeting and reporting meetings be February and September in the future.

STAFF REVIEW

The two papers as originally sighted by the Staff Sub-committee were included in the EC papers.

Recommendation: The position of NZKC Events & Administration Coordinator be advertised immediately within the scope and financial constraints that currently exist.

Moved ST; Seconded GC - passed

It was noted that the original JD is not changing but the title is, from Events Manager, to better reflect the actual duties.

Ensuing discussion requested that PD provide overall income and expenditure figures from the past 5 years.

BREEDERS CODE OF ETHICS (BCOE)/REGISTRATION REGULATIONS REVIEW

It was agreed at the November meeting that the BCOE was embedded, as appropriate in the Registration Regulations, and conversely reference is made in the BCOE to the Registration Regulations. Drafts of the recommended changes were placed in the EC papers. Given discussion on what penalties should apply it was agreed that the matter be held over until April. PD noted the small numbers affected by the breaches.

At the suggestion of KM, PD had previously sent the draft recommendations (from the Registration Regulations) to the Breed Standards committee. These related to "Special Conditions for Registration in Certain Breeds" as there was either no consistency in what Register such dogs should be placed on and/or they required updated from impending changes. PD requested KM to follow this through given its relevance.

BREEDERS CODE OF ETHICS (BCOE)

Becky Murphy (BM) & PD had reviewed the BCOE as requested with recommended changes sent to the CH&W committee before being tabled at that committee's 17 February meeting. The notable changes were:

- 1. I will not transfer from my care any puppy under the age of eight calendar weeks. Three days leeway is provided for collection over the previous weekend. An exemption for a period greater than three days must be approved in advance by the Director Secretary.
- 2. I will not breed more than two litters from the same bitch within 18 months without the prior approval of the Canine Health & Welfare Committee."
- 3. In exceptional circumstances administrative discretion (Registration Regulation 4.3) will apply to the conditions set out in this code where it is deemed to be in the interests of the welfare of a dog or dogs and/or the integrity of the NZKC.

Moved ST; Seconded GC -passed

The amendment reflecting penalties is held over until April.

BM is to develop criteria for the CH&W committee where prior approval is requested for exemptions to the code.

KM suggested the code could be renamed to Minimum Standards but it was noted that many organisations have codes of ethics in place.

2018 CALENDAR CHANGES

Following communication with the affected clubs (25) Colleen Begg is to update accordingly with a draft to go to EC for approval prior to being circulated. PD noted that this will require, in some instances, clubs not being satisfied with the outcome.

2017 ACOD

A copy of the February ad from the Dog World and the 2017 timelines were included in the EC papers for sighting. With EC have already determined that a forum be held in the afternoon on "increasing membership" PD suggested that an outside party be utilised to facilitate the session. One such party had recently approached NZKC with a cost yet to be determined there were a number of options available where there were little or no costs attached. One of these would be Sport Wellington. GG to approach a person known to her as another option.

Other considerations for the day were:

A draft timetable was formulated:

Once finalised the format will be advertised and, as agreed in November, all clubs will be invited to attend. The relevance of ACOD to all clubs is a question for feedback in the survey to be sent out shortly.

2017 NDS

Gary Withers (Chairperson) provided an updated report.

- Auckland Council (Animal Management) approached for funding in lieu of free stand with this covering the cost of the media package. A repeat of further funding from the council may be difficult with the sad loss of Clyde Rogers, the 2014 NDS contact.
- Discussions held with Tui McK. re live streaming. Media Works providing offer as in 2014.
- Meeting with Masterpet NZ scheduled for 28 February. PD to attend.
- Sash donors being approached shortly. Advertising being sought from local businesses.
- Target of 40 supporting shows looks achievable.
- YKC Finals venue yet to be determined. Offer on table from Prelude committee.
- Grooming spaces being confirmed to office in near future (about 200).
- Catering requirements to also be discussed shortly.
- Accommodation secured close to airport.

GC advised Working Trials (WT) & Rally-O judges being approached with contracts to follow. GC advised Rena Shaw is Auckland contact for WT display. PD to advise NDS committee. SM reported that the contracts (judges) are too loose. PD to discuss with Christine Wood but reported they are same as used in previous years. Request for Prelude to use Gloria Landon's show programme. PD to check office implications. PD to follow up on availability of Mayor. PD to follow through re YKC finals.

2018 NDS

Dates confirmed as Friday, 5 October to Sunday, 7 October. In late January Sue Conner and PD went to Fielding (joined by Becky Murphy as she lives there) to investigate Manfield as an alternative to Porirua in the staging of the 2018 NDS. Still awaiting information on the venue. Once received options will be set out for EC to determine venue. Manawatu KA remain as option to host Prelude.

4. OFFICE REPORTS

DIRECTOR/SECRETARY REPORT (Matters not reported elsewhere)

- Rebranding reminder that, if no objections are received, all 3 logo-marks will proceed to registration no later than 25 February.
- Recommendation that for the sake of transparency to the membership the
 difference in budgeted cash surplus and actual cash surplus be reported in the June
 Dog World as applied with the FAR in 2016. GS & PD to draft article highlighting overruns to include legal expenses. Reference to be made to respective cases rather
 than names.
- All Staff Performance Reviews have been completed with reports dually signed. An
 overview was provided in relation to Becky Murphy after Year 1 in her role. Similar
 process had been undertaken with CH&W committee. Agreed that administration
 work should be minimised. PD noted that this will apply with JD to be updated even
 though the impact will be minimal.
- Reported on 2nd NZCAC meeting attended (first as appointed NZKC representative)
 and the two member forums (second with Becky Murphy). PD to circulate forum
 schedule to EC. They are now being held in four centres throughout NZ.
- Update provided on On-line Show Programme (OSP). 92 clubs (32% of member clubs) have now utilised the OSP. Latest improvement is the capture of results and display of these. A manual for clubs is now also available.

TREASURER'S REPORT

GS in attendance on Sunday, 19 February.

• December and January financial reports (summarised) were tabled. The A&R Subcommittee had previously received full sets relating to November, December and January. The net cash surplus to January 31st stood at \$18,025 against a budgeted figure of \$104,215 and a last year figure of \$196,965.

- The forecast cash surplus has been adjusted to \$20,935 against a budgeted figure of \$101,534. This is an improvement of \$20k from December 31st and relates to expenditure.
- Total cash at 31 January was \$1,299K and up from last reported (to November EC meeting) figure from October \$1,235k.
- Overall income at \$1,573,240 on par with budget with expenditure of \$1,555,215 up \$86k.
- The 2016 NDOA showed a variance of \$14k (negative) from budget. Agreed that in future NDOA have its own code and that the budget be approved by the Obedience committee.
- Agreed that, for reporting purposes, the three Obedience regions be combined.
 Internally nothing will change.
- Discussion on whether NZKC should go to market for major sponsor i.e. beyond period of 31.12.17. PD indicated that he is to respond to recent queries from Purina who have indicated interest in the past if there was not a singular sponsor. Agreed that the topic be an April agenda item.

2017/2018 Budget

- A first cut, two page summary was presented by GS who is still awaiting detail from a number of committees. PD indicated that, ideally, these should all have been received by now and that a full draft of the budget was presented at this, the February meeting.
- Once all detail has been received an updated version will be sent to A&R. If any amendments are required this will be made and the amended document sent to FC.
- The finalised version (summary) will be provided in the April EC papers for formal sign off prior to publication the Yearbook.

CLUB & MEMBERSHIP MANAGER (Colleen Begg)

• The Saluki Club has paid its annual subscription and wishes to continue. A decision will soon be made re status i.e. associated or recognised. Recommendation that club be allowed to continue as described.

• The Southern Irish Setter club seek approval to fold and allow the Irish Setter club to include the South Island in their communications and services (Z'sOI no longer apply). Assets to be transferred to the Irish Setter Club. Agreed to waive this year's annual subscription.

- Wellington & Districts Boxer Club & North Canterbury DTC's changes from associated to recognised societies were noted.
- Annual club and PL accounts have been combined for 2017/2018 and will be emailed rather than posted. This will happen in the first week of April.
- Currently 15 clubs have applied for shows to be held in conjunction with the 2017 NDS.

CH LORD BRACKEN OF LAVENHAM 03216-2013 Collie (Rough) owned by R J & D Baker and J Madeley

This dog has completed 6 favourable observations and is no longer on report. The owners have been advised.

EL-TORO DAMASCUS 03815-2016 Chihuahua (Smooth Coated) owned by J Moss

Having been placed on report this dog has undertaken show training. After being entered for January shows with an observer appointed it was subsequently withdrawn.

KERRYBRENT ISHA LADY LUCK JD 00376-2013 Border Collie owned by S Robertson

This dog has completed 6 favourable observations and is no longer on report. The owner has been advised.

CH DERINGOLSTA PETRA 06986-2014 German Shepherd Dog owned by G & D Ingham

This dog has completed 6 favourable observations and is no longer on report. The owners has been advised.

ROSKI AIN'T NO ILLUSIONZ 05612-2015 Boxer owned by K & R Mihaka

This dog has been placed on report for attacking another dog in the ring at the Kapi-Mana KA show on 15 January, 2017. The Show Manager advised the handler of the 7 day stand down period and the office has advised the owners of the observation requirements.

LORDE OF CHARLESWORTH 04460-2014 Golden Retriever owned by S Charlesworth

This dog has been placed on report for attacking another dog outside the ring at the Northland CA show on 21 January, 2017. The Show Manager advised the handler of the 7 day stand down period and the office has advised the owners of the observation requirements. The owner of the other dog advised there was a puncture wound and it is on anti-biotics for this. He also advised that his dog is a bit wary of other dogs but is under socialisation as a result.

CH LOCKBURN BLACK VELVET 04340-2011 Border Collie (Rough) owned by P Hill

This dog has been placed on report for biting a child in the face at the Nelson District KA show on 21 January, 2017. The Show Manager excluded the dog and advised the handler of the 7 day stand down period. The office has advised the owners of the observation requirements. The mother of the child advised that emergency treatment was not required.

SONNENSCHIEN EBONY ROSE 04697-2013 German Shepherd Dog owned by P Coleman

This dog has been placed on report after being excused from the ring by the judge at the SI German Shepherd Dog League's Open show on 6 November, 2016. The judge advised that "the dog's behaviour towards other dogs was not correct in that it was unruly and barking at them". The office has advised the owner of the observation requirements who made note of its inexperience in the ring.

ASTUTO LOVEMETOO EVA 04497-2016 Fox Terrier (wire) owned by J Campbell

This dog has been placed on report after being dismissed from the ring by the judge for snapping at him at the Hibiscus Cost KA show on 28 January, 2017. The Show Manager advised the handler of the 7 day stand down period and the office has advised the owner of the observation requirements who reported that the dog may have had a sore mouth after having an embedded grass seed removed from its mouth by a vet. The dog has undertaken one favourable observation.

SHALU TAKE A CHANCE ON ME 01657-2016 Lhasa Apson owned by S Walton

This dog has been placed on report after being excused from the ring by the judge for growling at her at the Central NI Utility & Non-Sporting Dog Association's show on 4 February, 2017. The Show Manager advised the handler of the 7 day stand down period and the office has advised the owner of the observation requirements. The judge has been asked for a report.

APPEALS

1) OAKWAY URBAN ANGEL 02718-2016 – German Shepherd Dog owned by P & L Halliwell The dog had previously been placed on report and at its first observation was dismissed from the ring by the judge for aggressive behaviour. Under Show Regulation 19.13.3.4 it was then declared ineligible for exhibition at any NZKC show. The owners appealed the ruling for

consideration at the 26/27 November EC meeting. EC asked that the observer's report be tabled before a decision was made.

The observer's report was made available for the February meeting as was a favourable report from Christine Nielsen (NZKC member, private trainer and CGC Committee member & CGC Assessor). Recommended from the table that, in light of the observer not being present at the time of the incident and the favourable dog training report, the dog not be declared ineligible but rather commence its 6 observations again.

2. CH RAHKANTRA DIAMONDS ON ICE 05801-2008 German Shepherd owned by C Orchard

Owner had submitted an appeal to have the Previous EC decision reviewed. i.e. dog declared ineligible for exhibition and only able to taken to a show if kept in a vehicle or cage or muzzled if on lead.

PD to write to owner reconfirming current status and to club advising of action that should be taken with local Dog Control (check previous Gail O'Keefe advice). Latter is to be part of BW & PD review of Exclusion of Dogs.

CANINE HEALTH & WELFARE OFFICER (Dr. Becky Murphy)

- Invited to present (NZKC initiatives to improve pedigree pure-bred dog health) at the Australian & NZ College of Veterinary Scientist's Conference (Science Week) on the Gold Coast, Australia from 6-8 July, 2017.
- Accredited Breeders membership still under review by CH&W committee. Reasons for resignations clearly a consideration moving forward. Numbers have increased from 88 (March 16) to 97 (January 17).
- No LRL submissions received so will proceed to next step.
- First Brachycephalic Working Group meeting held on 16 February. EC suggestion that
 other (brachycephalic) breeds be involved. PD advised that is a next step in
 process. Consideration also to be given to health matters being notified on judging
 forms. Meeting also advised that some airlines will not transport bulldogs or only with
 waiver of any responsibility.
- At request from EC the implications of DNA testing for exported dogs were investigated. This was set out as being the cost but EC did not see this as a major deterrent given the benefits. Proposal to move to next step i.e. advertising of the initiative.

DISPUTES

The other case was to be supported by video evidence. At this point nothing conclusive can be seen from what has been provided. Given that the veracity of the complaint will be reviewed.

OBEDIENCE COMMITTEE

- Meeting held on 11/12 February (last weekend). Meeting is the one 2 day meeting held per annum to include focus on strategic matters. Focus this year was on Domestic Dog Training Conference.
- February Discussion Items have gone out before voting on in April. Survey Monkey will be used (first time) for the voting round.

- Nominations called for 3 Region Reps and Chairperson. Due mid-April with elections held in May if required.
- On-line show results well received by Obedience community.
- Three Judge appointments requiring ratification:
 - o Fiona Scott to Rally-O Novice panel
 - o Karen Browning to Obedience Open Trial/Ribbon Trial panel
 - Jeffrey Walkington to Obedience Open Trial/Ribbon Trial panel

Moved GC; Seconded ST – ratified (effective immediately)

Domestic Dog Training (DDT) Conference (22/23 July 2017 in Wellington)

Planning for this inaugural Conference was dealt with in detail at the DOC meeting held last weekend after notices had been placed in the Dec/Jan Dog World and clubs (46) written to in December, 2016. Detailed notes were circulated to the DOC committee this week as was a draft budget. Both are available upon request from Executive Council bearing in mind both are in draft form and for discussion by DOC. The budget has been put in place in an attempt to attract attendees from as many of the 46 member clubs as possible and not have the costs deter them from attending. As is stands it will cost a club \$150 for a Travel Equalisation Levy, \$75 to register and \$50 to attend the Awards Dinner (optional). For a second (club) person it would be \$75 to register and \$50 to attend the Awards Dinner (optional) plus flights (if applicable) and assuming a shared room. The NZKC cost has been factored into the 2017/2018 budget at \$14,000 which assumes the Gaming Trust application is unsuccessful. If successful the NZKC will be reduced to \$4,000. Attendance will be open to all clubs but with no subsidy applicable. Support in principle sought from EC.

CANINE GOOD CITIZEN

Report provided by Rosemary Cleator (Chairperson)

- Concern raised over cost and time involved in change from Eukanuba to BlackHawk.
- Noted again (second time) that CGC is being referred to as Bark NZ programme on TV dog show. This is happening due to a conflict in pet food sponsors. Pointed out that it could be referred to as NZKC programme. PD to follow up.
- 2017 CGC Manual finalised and distributed.
- Canine Good Basics programmed to be launched at DDT Conference.

NZDJA

Report/s provided by Martin Hewitt (NZDJA Chairperson), Debbie Hull (NZDJA Secretary) and Kathleen Hardwick (acting on behalf of NZDJA Secretary)

Board meeting held in January, 2017. Dates set for Theory & Practical examinations. 31 persons approved to sit examinations (across all levels). Draft amendments made to Judge's Regulations to be taken to membership for ratification. A proposal to allow existing Group & All Breed judges to be listed on Specialist panels will also be put to the membership. Given feedback on the compulsory Annual Practising Certificate a voluntary system will be discussed at the July AGM in June. The Board is looking to put in place a regulation which deals with cancelled shows and judges requiring those appointments to advance. Regulation to include the number of dogs judged and whether the Group can count.

Judge appointments and promotions (for ratification)

Aspiring Judges Panel
