President's Annual Report

This is my second report to the Club as President and it has been a challenging year as government agencies have moved forward with legislative change to the Animal Welfare Act. We are currently being consulted on proposed regulations likely to be introduced later this year. As a result these regulations will impact on the standards of care and conduct towards animals and in particular on surgical and painful procedures. The Act does not



expand on care and conduct obligations, but it does set out minimum standards in the Code of Welfare, which are now supported by regulation and lower level penalties (based on frameworks used in other similar legislation). The first tranche of draft regulations are being consulted on at present and the office and I have been representing members at various meetings and encouraging members to attend public sessions so they are fully informed of the issues at stake. I will discuss this issue in more detail at the Conference but at this point we are only at the start of a process and the issues being addressed are those that Government officials believe they can get over the line with minimum effort. However, members do need to get engaged in this process and not leave it to others to submit on your behalf.

Financial

The financial position of NZKC is strong and while there was a small drop in total income (24,712) there was a corresponding drop in total expenses (88,395) resulting in a net cash surplus of \$220,890.

Our Treasurer will report in the *NZ Dog World* (June 2016 edition) on the extraordinary item which is a write-down of fixed assets so I will not go into this in detail apart from acknowledging that as a result of decisions made in prior years to capitalise significant items of expenditure in relation to both the Auckland and Wellington properties, NZKC is now in the position that it needs to write down its fixed assets by \$376,402.

Executive Council has taken advice on the best way to do this and determined that it is best to do this in one year given the current strong financial position of the Club.

A breakdown of our transactional activities follows.

A lot of people contributed well during the week and I thanked all of them through my article in *NZ Dog World* but it was a great example of the dog fraternity working together irrespective of where they came from for the greater good. Well done to everyone. For me a highlight was the great television and media coverage.

NDOA and NZDAC

Both events ran successfully with strong attendance. This year I attended the NZDAC held in Tokoroa and thoroughly enjoyed myself. Over 4500 runs delivered over three days, live streaming via the internet. The event was massive with activities consuming what is a massive park and complex. It was impressive to watch and be a part of. It was good to see the South Waikato District Council well engaged and the Mayor opening the event. It is easy to understand why agility is the fastest growing aspect of our sport.

Properties

I touched on the upgrade of Porirua as part of the report on the National Dog Show. However, good work continues with the teams at both Ardmore and Forrester Park both having refreshed their committee membership and leadership. Ardmore has recently introduced a Health and Safety Plan which is being used as a template for other sites and they have upgraded their kitchen facilities and are working towards a significant upgrade of their toilet facilities and completion of their sewerage consent. At Forrester Park the judges' room and secretary's office has been refurbished and fire exit doors repaired.

Canine Health and Welfare

One of the major achievements this year has been the appointment of a Canine Health and Welfare Officer – Becky Murphy – a practising veterinarian. Becky is a former member of NZKC who was a successful Junior Handler and exhibitor of Dobermanns and Beagles from Nelson. Since graduating from Massey University with a degree in Veterinary Science and a BSC in genetics, Becky has been working in Fielding and was the Honorary Veterinarian for the Manawatu Kennel Association. Becky has strong ties with the dog scene, breeders and our issues and is a really good fit for the Kennel Club. While the role is part time she has already demonstrated a great capacity in terms of output. Becky is providing support to NZKC's Canine Health and Welfare Committee as well as technical input to our submissions to the Ministry for Primary Industries. The Kennel Club when submitting needs to be able to demonstrate good science, robust practice and technology. Becky has also been running breeder seminars for member clubs and breeders throughout the country.

While on the topic of Canine Health and Welfare, recommended tests for breeds have been advertised through *NZ Dog World* for feedback. We do need to stay informed and think about the things we as breeders need to do to ensure we are producing healthy and fit for purpose puppies. Canine health and welfare does matter!



In addition to appointing Becky this year NZKC adopted a mandatory code of practice for all breeders and has introduced compliance standards to be met before you will be able to register and have a kennel name approved. These compliance standards are intended to provide some quality assurance around the performance of our new breeders.

Strategic

Council has refreshed and signed off its strategic plan. Alongside this we have adopted a communications plan which I overviewed in my May editorial. In terms of communicating with members greater use has been made of *NZDog World* and survey tools seeking feedback from members. We are getting mixed responses so are keen to understand the best way to communicate with members. The intention is to make more use of the website and social media tools. Information regarding the Animal Welfare Amendment Act was posted on the website and we did a direct mail out, but a lot of those emails landed in peoples spam boxes so unless you saw these you failed to see the mail out unfortunately.

At this conference we will be workshopping two key issue with delegates:

- 1. The plan to position NZKC under the banner of Dogs New Zealand.
- Dangerous dogs what role and response should NZKC be delivering?

We are interested to hear from you, so please discuss these topics with your committees and members and come ready to discuss them at Conference.

People

Thank you to Peter and the team in the office for a sterling effort during the year not only in their day to day jobs but in the way they stepped up during the National Dog Show. The effort was appreciated.

Members, your contribution to the organisation is considerable and this year for the first time we are introducing a new award acknowledging outstanding contributors through our Breeders Hall of Fame and there will be two inaugural inductees at this year's Annual Conference of Delegates.

Finally, thank you to the team and congratulations to Maree McKenzie and Steve Tate on being returned to Executive Council for a two year term unopposed – a first for the North Island for a long time. There was an election in the South Island with three candidates standing for two positions. The outcome of that election will be announced at Conference. There will also be elections for the North Island and South Island Vice Presidents and Senior Vice President.

Committee Reports

Agility

Agility continues to grow and is continuing to be a sport that attracts new people to it. Our National Championship attracted 4,500 entries over four days in Tokoroa this year demonstrating the health the sport is in.

Organising NZDAC is a task done solely by volunteers and it is a testament to those people how every year we can write and say what a successful National Championship we have had. Tokoroa was no exception with a great venue able to accommodate the show and over 100 campers all in the same venue along with the social functions.

While the competition side of the sport is in a great state, the administration side of the sport still needs to follow the success of the competition side. It was disappointing that we only had enough people to fill the vacancies on the committee and we had no need for an election. At a time when good management is needed, good ideas need to come forward, and we need skilled people to lead the sport, we do not have a contested election.

One of the key challenges facing this agility committee is how do we foster an interest not only in competing, but in building systems for the future of the sport? Because without a good structure the sport is again likely to get speed wobbles.

The Agility Committee has done a lot of work around safety with the WOF process for gear, ensuring the gear not only meets regulation but is safe for dogs. While the first inspections have been completed, it is important for clubs to maintain gear up to a WOF standard. Most of us do not like being told what to do, but with changes to the animal welfare code it is important our sport demonstrates that we are taking animal welfare seriously and only having equipment that has passed a WOF at shows.

One of the challenges facing the NZKC is all disciplines holding their National Championships during October. We have surveyed members and got an overwhelming response that our current dates are the most preferred by the agility community. With Agility being the only National Championships being held outdoors the agility committee is still advocating Labour weekend as the most preferred weekend for NZDAC.

The other real challenge for our sport is geographical. In the top half of the North Island it is not uncommon for shows to have 2,500 entries making running a competition difficult for small clubs. It has been great to see a number of the clubs in this region combining to make running the show possible. We have seen some very well run shows as a result of this.

What is becoming apparent is that management of the sport is changing depending on where in New Zealand you live. Future changes to the sport may have to be built around this as more of New Zealand moves north (60% of New Zealanders now live north of Taupo)

On a personal level I have been involved in agility for over 20 years. What keeps me passionate about the sport? I get my enjoyment out of the fun I have with my dogs, seeing their absolute delight in doing something fun with me, and seeing me get better as a handler. I am still looking for that elusive perfect round, but if I can come out of the ring knowing that I have given it everything I can then say, its been a win for my dog and I.

Breed Standards

The Breed Standards Committee met four times during the year via teleconference and also conducted some matters via email. We reviewed a number of items referred to us by Executive Council and also submissions received from clubs and individuals.

No new breeds were recognised during this year. However, the Peruvian Hairless Dog was moved from the Non-Sporting Group to the Hound Group. All Hound judges who were not Non-Sporting judges at the time of the original breed recognition will be required to sit and pass an Open Book examination on this breed.

The Peruvian Hairless Dog had a new FCI Standard published which allowed for a coated variety. This Standard was adopted for all three sizes of the breed.

Two breeds had new standards adopted in full. These were:

- Affenpinscher (American KC Standard)
- Italian Greyhound (The Kennel Club (UK) Standard)

The Breed Standards Committee works to a number of protocols and one of these is keep our Standards aligned with one of the major controlling bodies around the world, these are normally FCI, American KC or The Kennel Club (UK). This year a number of small changes were made to some of these Standards and these new amended Standards were recommended to be adopted. These include:

- Fox Terrier
- Schnauzer (Miniature)
- Portuguese Water Dog
- Weimaraner
- Welsh Corgi (Cardigan)
- Bichon Frise

The Committee has discussed the interbreeding of Belgian Shepherd Dogs and at this stage has not recommended that this be allowed. This matter raises a number of issues not only with these breeds but other breeds as well. There are also implications beyond just the Standards as it will also affect Registration Regulations and the Health Subcommittee.

A number of discussions were held on the layout of breed standards and also noting where their origins came from. At this stage the matter is still under consideration.

Finally, I like to take this opportunity to thank the members of this committee, Annette Buxton, Karen McIntyre, Pam Douglas, Wendy Schwalger, Maree MacKenzie and Keith Brown, for their work and contribution during the year.

Canine Health & Welfare

The objective of the NZKC Canine Health & Welfare (CH&W) Committee continues to be to investigate health issues affecting the various breeds NZKC members are involved with, and to encourage sound breeding practices, including the reduction/elimination of significant inherited disease without reducing the genetic variability available to breeders in New Zealand.

This year we welcomed Dr Becky Murphy who has been employed by NZKC as the Canine Health & Welfare Officer. Its a role that no doubt will grow as our canines come under further scrutiny from outside sources. One of her objectives is to go around the country running meetings with breeders. The schedule for these has been advertised in the April issue of NZ Dog World and on the website. Please try to attend one in your area.

The committee again published proposed changes to the health testing as required by the Accredited Breeders Scheme, received submissions, reviewed again and then re-published the additions and alterations of testing requirements for some of the breeds. Canine health issues worldwide and the testing regimes are rapidly changing with new DNA tests becoming available and as such we do this yearly.

We still need to collate accurate information and feedback regarding the incidence of inherited disease for our different breeds. At present there is only the limited information we have received from accredited breeders as to the incidence of disease within breeds. We would encourage breed clubs to collate data for their breeds, which includes results of verified health tests. There has been information collected from Veterinary Surgeries where the difference between Pedigree Registered dogs is not distinguished from purebred and possible cross breed dogs. This information could be used to seek controls put on pedigree dog breeding in the future. We are not scare mongering but are very aware of the possible future direction of Government policy.

To this end NZKC is looking at a computer programme that will allow the imputation of health results, thus giving us information on what our breeders are already doing. This will also allow the printing of certain results on a pedigree. The CH&W Committee have very carefully selected the tests per breed that they recommend to have available for printing. There could also be the facility for a breeder to pull up and print out all tests they have undertaken.

We have been working with Dr Becky Murphy on a submission from NZKC in reply to NAWAC opinions on Selective Breeding and Animal Welfare.

The 2015/2016 year has seen obedience competitor numbers hold reasonably steady but we need to consider ways to attract new competitors and retain existing ones to avoid a gradual decline in show entries. It is important to ensure there are incentives for both the serious competitor at the top end of the scale as well as the new and social competitors at the other end of the scale. Motives for continuing in competitive Obedience, Working Trials and Rally-O vary from person to person, ranging from gaining placings, awards and titles to personal satisfaction and the social aspects of attending shows. We need to make sure we cater for all these people if we are to grow numbers and ensure we survive into the future.

Another important focus for the Dog Obedience Committee is to support our dog training clubs with their programmes of domestic dog training. There are around 50 dog obedience clubs around New Zealand that conduct regular dog training classes for members of the public using the principles of the NZKC's Canine Good Citizen Programme in an effort to create well-mannered dogs and to promote responsible dog ownership. This is an important public service provided by our obedience clubs that goes largely unrecognised and unappreciated by councils, government and the public in general. Our aim is to raise the profile of these programmes, provide additional support for our clubs and to work with local and national government to maximise the exposure of the Canine Good Citizen programme.

Committee Elections

The two-yearly election process for the three deputy regional representatives on the Dog Obedience Committee was conducted in April 2016. The following people were all elected unopposed:

Northern Region Deputy Representative: Karen Browning

Central Region Deputy Representative: Lee Engert

Southern Region Deputy Representative: Alastair Kirk

The Central Region Representative on the Rally-O subcommittee, Helen Carter, was also re-elected unopposed for a further two years.

Thank you to those who put their names forward for these positions. The Dog Obedience Committee (as with all our club committees) can only function with dedicated volunteers. Also thank you to Stephen Harris who is stepping down as Central Region Deputy Representative on the Dog Obedience Committee after serving in that position for the last four years.



National Dog Obedience Assembly

In 2015 the NDOA was hosted by the Southern Region at the Riding for the Disabled venue in Christchurch over Labour weekend. This was an excellent event at a great venue (which will also be used for the 2016 National Dog Show).

We are looking forward to when the major events are spread throughout the year rather than having the agility NZDAC on the same weekend as the NDOA with the National Dog Show only two or three weeks before. This still requires some negotiation to determine the best mix of dates for the three major events but we are hoping to make some progress on this soon.

Voting Registers

The voting registers are now fully operational and have simplified communication with Obedience, Working Trials and Rally-O individuals. These are tied to the NZKC membership database. The registers have principally been used for the discussion and voting rounds on regulation changes, but are also useful for the distribution of other information.

Finally, thank you to my fellow committee members and all those in the Obedience, Working Trials and Rally-O communities who have given their support and time over the year by taking part in club, regional and national committees and meetings, conducting dog training classes, running and entering shows, and providing feedback through the surveys and the obedience voting process.

I start this report by saying thank you.

Thank you to all the clubs and exhibitors who support us throughout the year. We stand at the gate on every major show weekend rain or shine and hold out our buckets, and our exhibitors and visitors are always willing to



donate. These contributions along with the great entries and support that we receive for our benefit shows and our annual Dog of the Year Awards(DOTY) event, help us to maintain our standards at the grounds and assist us in the funding towards major projects.

Our financial situation is healthy this year and we expect a profit of approximately \$26,000 before Depreciation. This in part to \$13,500 profit from our benefit shows and \$1,000 profit from DOTY. The donations from the gate area are approximately \$400.00 each time. With cash surplus from previous years and continued support from gate takings we have bigger plans for improvement projects for our grounds.

This year we have once again made significant progress on a range of property improvements and enhancements that are aimed to deliver long–term benefits to the AEC property and dog community who use it.

The PA system was over 14 years old and had become problematic, so sound experts were called in to re-vamp what we had and replace where necessary. We now have a single system for both inside and outside, special sound mixers especially inside where our acoustics can never be perfect, and a tamper proof on/off system that delivers what we have at the touch of a single switch.

Over the last year our biggest project has been the water collection and filtration system. We de-commissioned the bore water system and installed in its place three new rainwater catchment water tanks along with a safety fence. This now gives the grounds the very highest standard of water. New local council requirements have also impacted on our sewage/ septic system, and thankfully they, the councils, have acknowledged that such major changes are unable to be sustained by organisations like AEC. With some fine tuning of our current systems we will be able to buy some time, approximately five years, before we are faced with the full impact of their new proposals. This eventual upgrade will see enhanced purity of the final soakage system where hopefully above ground soakage will be permitted. Our goal is to future proof this system so that it will not require ongoing upgrades every year.

We have also taken the opportunity to revamp the kitchen in the barn that is available for our clubs to use. The makeover has provided the clubs that utilise this kitchen with appliances that meet the food safety standards along with creating a better environment for them to work in.

Health and Safety has also been a focus for us over the last year. We have put in place a Health and Safety Management plan and have also developed a plan for continuous improvement in this space. We feel the Health and Safety needs to be a major factor in all of our shows and will be working with the clubs that use our grounds over the next year to share our vision for safety at the AEC grounds.

I would like to close with another thank you. The AEC committee has also gone through a revamp during this year, and the committee has been incredibly supportive while I find my feet in the role as chairperson. I would also like to thank those who have joined us this year and the committee members who have stepped up and taken on new roles. It is great to see that the AEC committee will always strive to evolve, and continue to grow to manage our great facility. We receive and rely on extra support of our community and members and without this help, we could not operate the grounds on a daily basis. So to those who get handed a shovel, bucket and a hammer and still keep coming back I give the biggest thanks of all.

The maintenance and upgrading programme for the Forrester Park property has continued throughout 2015. The replacement of the Clearlite roof panels has been completed with the installation of Wonderglass panels. This has been a very successful project; the building is much brighter and warmer. The roof is



again weatherproof as it has withstood some heavy rain and has also endured a severe wind storm. The roof was also bird proofed and this has also been successful as there is no evidence of birds inside the building. It is great to have a weather and bird proof building again. We have also erected a Wheelie Bin enclosure so the bins are no longer stored inside. Grateful thanks to Lindsay Bryant for his work designing, pricing and building this facility. The sound system has been upgraded and the refurbishment of the Judges, room and Secretary's office is now complete with the laying of carpet tiles.

Following the unfortunate resignation of our long term cleaner, the cleaning of the hall is now being done by OCS (Outsourced Client Solutions) and this seems to be working well.

Our three August Championship Benefit Shows were very successful. Once again we are very grateful for the great support received from Otago Canine Training Club for their superb catering, the Otago Kennel Club and Southern Ladies Kennel Association for all their support and help with running the shows and providing lovely meals for the judges. Grateful thanks also go to all the local businesses and individuals who gave so generously of their donations, time and support.

With the change in the Dunedin City Council bylaws covering freedom camping there was concern as to how much this would affect competitors wishing to camp on-site. There was much discussion involving NZKC, Forrester Park and the DCC with the end result being that, effectively, there will be little change in the ability to camp overnight for shows, the major change being competitors will have to notify the club of their intentions.

The Dunedin property continues to work to budget and we are grateful to the major sponsors, Eukanuba and Interislander. The committee is very appreciative of the financial assistance given for help in maintaining the property to a high standard for the use of all NZKC members in this region. We are indebted to Southern Ladies Kennel Association for their donation of the proceeds from their Benefit Show, which will go towards

upgrading the ring equipment. Otago Kennel Association has also advised they wish to donate funds towards upgrading the kitchen. Again, we are very grateful for this support.

The Porirua property (Eukanuba Wellington Event Centre) has achieved an operating surplus for the year ending 31 March 2016 of \$40,655 which is \$4,740 up on budget. The corresponding surpluses in 2015 and 2014 were \$37,225 and \$34,010 respectively. Income this year was down from



the previous year by \$7,726 which was offset by a fall in expenditure of \$11,156. \$4,500 of the decreased income was due to the change in policy where interest income is now shown against NZKC rather than the Wellington venue. The main savings in expenditure were related to repairs & maintenance (\$7k), insurance (\$2.5K) and electricity (\$1.5k). Once again four Benefit Shows were run by the membership contributing \$12,000 to the venue's bottom line profit. The time and effort by those involved is truly appreciated.

2015 saw the return of the Eukanuba National Dog Show to Porirua. The 2014 event had been held in a commercial venue and this worked very well for our Auckland based organisers and the NZKC. In 2016 another commercial venue will be utilised in Christchurch so the pressure was on somewhat in 2015 in how the NZKC's premier event would be received being staged in one of our own venues. It is fair to say that the venue and the volunteer base, supported by NZKC staff, coped very well in providing an excellent show for both the exhibitors and the public. The public of course included all of New Zealand with the Best in Show highlight's package presented later in October on TV3. The event itself produced a profit of \$12,800 and that was after the unbudgeted cost of the NZKC share of the television was covered.

The staging of the 2015 Eukanuba National Dog Show in Porirua was also the opportunity to reinvest the profits from previous years back into the venue. Leading into the show LED lighting was installed and astro-turf was laid in the Side Hall. In addition, the "loud" blue colour was replaced through a repaint to freshen up the interior of the venue. Overall, the feedback from the members was very positive and signals the importance of reinvestment to the members and not only in Porirua but Ardmore and Forrester Park as well.

The annual meeting was held in May with the resident Wellington clubs. This is a key communication tool for NZKC moving forward and proved once again to be an ideal opportunity to report on the year past and what is planned in the next. The 2014 meeting saw a group formed to stage two extra benefit shows and these have now been held in 2014 and 2015 as

they will be again in in September, 2016. These two shows take the total being run in the venue to the maximum allowable of four with all proceeds going to specific projects. It is therefore once again relevant to note and thank Gary Carleton and the team from the Hutt Valley Kennel Centre for their on-going support of the venue in the staging of two benefit shows per annum. The other two shows are staged by a small group of volunteers and staff ably led by Carolyn Stevens and Bill Crawford.

It is very important that the venue continues to show surpluses given the age of the building. The roof in particular remains a concern and at some point in the near future will require significant investment. Whether this is by way of an interim measure or something much more significant will likely be a consideration for Executive Council sooner rather than later.

Once again I wish to acknowledge the work of Shelley Gilliver (Events Manager), Graeme Sugden (Treasurer) and Brian Kell (Caretaker) in keeping the venue financially viable and attractive for our members and commercial partners over the past year. Brian's efforts continue to be well received by the venue users and of late Shelley has been busy in ensuring that the venue is health and safety compliant.

Remit 1 by the Executive Council

SECTION 111

AFFILIATED, ASSOCIATED AND RECOGNISED SOCIETIES

Proposed addition of another clause (iv) to Rule 8. (a) to give a further option for societies under which they may apply to become associated

8. ASSOCIATION OF SOCIETIES

- (a) Without prejudice to the right of any society which may be eligible to apply for affiliation, the following societies may, with the approval of the Executive Council, become associated to the New Zealand Kennel Club:
 - (i) Societies catering for all breeds
 - (ii) Societies catering for more than one breed from the same Group
 - (iii) Societies catering for breeds originating from the same geographical area but not necessarily from the same Group.
 - (iv) Societies catering for breeds of similar phenotype* but not necessarily from the same group.

Rationale

The New Zealand group allocation system often places breeds of similar type in different groups e.g. Bull Breeds, Spitz Breeds and Spaniels. This addition would allow societies to be formed to cater for these groupings of breeds.

* **phenotype** phe·no·type (fē'nə-tīp') n.

- 1. The observable physical or biochemical characteristics of an organism, as determined by both genetic makeup and environmental influences.
- 2. The expression of a specific trait, such as stature or blood type, based on genetic and environmental influences.
- 3. An individual or group of organisms exhibiting a particular phenotype.



Remit 2 by Executive Council

SECTION 111 AFFILIATED, ASSOCIATED AND RECOGNISED SOCIETIES

Remove Rule 11 and renumber accordingly.

11. ANNUAL SUBSCRIPTIONS

Every society affiliated to, associated with, or recognised by the New Zealand Kennel Club (under Rules 7, 8, 9 and 10 hereof), (except the affiliated member societies of the New Zealand Gundog Trial Association) shall pay in advance on 1st April each year (or starting with and upon first affiliation, association, or recognition), the annual fee as its subscription.

Rationale

Rule 11. Annual Subscriptions, as pertaining to member societies, is already set out under Rule 8A.1 and is therefore repeating the same information. The situation arose in 2002 when the new Rule 8A.1 (Rule 9A.1 at the time) was introduced without the removal of Rule 11. (Rule 12 at the time)

8A. ANNUAL SUBSCRIPTIONS 8A.1 Annual Subscriptions

(a) Every society affiliated to, associated with, or recognised by the New Zealand Kennel Club (under Rules 7, 8, 9 and 10 hereof), (except the affiliated member societies of the New Zealand Gundog Trial Association) shall pay in advance on 1st April each year (or starting with and upon first affiliation, association, or recognition), an annual fee as its subscription. Remit 3 by Executive Council

SECTION V

CONSTITUTION AND ELECTION OF OFFICERS

Amendments proposed to Rule 20 to provide further clarity on the requirement for Executive Council members to be delegates to the Annual Conference of Delegates.

20. CONSTITUTION

- (a) Delegates assembled at the Annual Conference of Delegates (and who are entitled to vote as detailed in Rule 16 hereof) shall elect a Patron. and Vice-Presidents. Nominations for President and those members of the Executive Council elected under Rule 20 (d) (i) (2) hereof, shall be called for by the Director/Secretary at least three months before the annual conference and be made in writing to the New Zealand Kennel Club. Nominations may be made by any Affiliated. Associated or Recognised club or any financial member of the New Zealand Kennel Club. Such nominations must be received by the Director Secretary by a date specified by the Executive Council. Nominations must be accompanied by brief biographical notes. In the event that these nominations are insufficient to fill the required vacancies under sub-paragraph (d) (i) (1) and (2) hereof, those nominated shall be declared elected at the Annual Conference of Delegates following their nomination. provided that they are delegates to that conference pursuant to Rule 15 or, in the case of an incumbent President, are eligible to serve a further term in that office. Any resultant vacancies shall be filled by nominations from the floor of the conference. Should nominations exceed the number of positions available. Rule 20 (b) shall apply. All nominees for election to the Executive Council must be delegates to the Annual Conference of Delegates at which the appointments are ratified unless:
 - They are current members of the Executive Council and are seeking re-election;
 - ii A retiring President shall be eligible for re-election whether or not a delegate.

All candidates are required to be a delegate when first elected to office provided always the retiring President, whether a delegate or not, shall be eligible for re-election:



- (b) (No change)
- (c) Subject to clause 20(a), if for any reason such nominee for office is unable to attend the conference, he/she shall still be eligible for election 'in absentia' provided that the Director/Secretary has received his/her consent in writing by letter or by email before the commencement of the conference. and provided further that any person so nominated is still a delegate pursuant to Rule 15. Any such nomination must be affirmed at the conference in accordance with Rule 16 hereof.

Rationale

A legal opinion was sought in 2015 in relation to ambiguity on this matter i.e. the requirement for Executive Council members to be delegates to the Annual Conference of Delegates and particularly in relation to a member unable to attend the conference. The amendments as shown are as provided by Gibson Sheat to provide the clarity sought.

Remit 4 by Dog Obedience Committee

SECTION III AFFILIATED, ASSOCIATED AND RECOGNISED SOCIETIES

Rule 9. Associated Specialist Breed Clubs (b) (c) (d) & (e). Originals (e) & (f) renumbered.

Proposal

To have written into the NZKC Rules permission for Specialist Breed Clubs, that also conduct regular obedience classes, to have the option to host All Breeds Championship Obedience Shows.

Rationale

For many years, a Specialist Breed Club in the South Island has been very successfully co-hosting an All Breeds Championship Obedience Show on an annual basis. Under the current regulations, however, this activity cannot be appropriately acknowledged or even recognised. Instead, the club has been required to remain a silent partner for another All Breeds Obedience Society. What is being proposed is merely making transparent an activity that has already been occurring for a number of years.

It is well understood why a Specialist Breed Club could not be permitted to host a Specialist Breed Championship Obedience Show, where Challenge Certificates are offered. However, there is no reason why a Specialist Breed Club, that conducts regular obedience training classes, and which therefore has a significant understanding of obedience show requirements, cannot have the <u>option</u> to host All Breed Championship Obedience Shows. As already stated this has been very successfully conducted for a number of years.

Whether or not a Specialist Breed Club wishes to host an All Breeds Championship Obedience Show remains <u>optional</u>, and an acceptance of this proposal **DOES NOT** obligate a Specialist Breed Club to host an Obedience Show at all.

Not only does an acceptance of this proposal legitimise an activity that is already occurring, but it also:

- i Enables Specialist Breed Clubs that conduct regular obedience training classes to gain greater financial income, rather than having to share costs with another All Breeds Obedience Society.
- ii Creates the potential for Specialist Breed Clubs to establish regular obedience training classes for their specific breeds.

The original rules include the phrase Specialist Breed Clubs (including in the title of the rule) and Specialist Clubs. To avoid possible confusion instances of the words Specialist Clubs have been changed to Specialist Breed clubs.



9. ASSOCIATED SPECIALIST BREED CLUBS

- (a) A Specialist Breed Club is a society which caters for one breed only (or for one breed Dog Training only), provided always that for the purpose of Rule 8 and this rule 9 (a) but for no other purpose, Pembroke and Cardigan Welsh Corgis shall be deemed to be one breed, and provided further that in the case of a breed in respect of which a separate register is kept for any variety of such breed then there can be a specialist breed club catering for any one such variety.
- (b) Specialist Breed clubs as defined in Rule 9(a) hereof, may with the approval of the Executive Council become associated to the New Zealand Kennel Club.
- (c) Specialist Breed clubs may, with the approval of the Executive Council, conduct Open Shows.
- (d) Specialist Breed clubs (but not Specialist Breed Dog Training Clubs) may, with the approval of the Executive Council, conduct two Championship Shows per year.
- (e) Specialist Breed Clubs compliant with NZKC Dog Obedience Regulation 2.4.1.2 may, with the approval of the Executive Council, host two All Breed Championship Obedience Shows per year.
- (f) The provisions of Rule 7, sub-clauses (b), (c), (f) and (g) shall apply with necessary changes to all Specialist Breed clubs.
- (g) The Executive Council may dissociate a Specialist Breed club from the Kennel Club for good reason.



- a) The preparation and fair presentation of the financial information in the performance report, which comprises the statement of financial performance, statement of financial position, statement of cash flows, statement of accounting policies and notes to the performance report, in accordance with Public Benefit Entity Simple Format Reporting Accrual (Not-for-Profit) issued in New Zealand by the New Zealand Accounting Standards Board; and
- b) For such internal control as the Executive Council determine is necessary to enable the preparation of the performance report that is free from material misstatement, whether due to fraud or error.

Auditor's Responsibilities

Our responsibility is to express an opinion on the financial information in the performance report based on our audit. We conducted our audit of the statement of financial performance, statement of financial position, statement of cash flows, statement of accounting policies and notes to the performance report in accordance with International Standards on Auditing and International Standards on Auditing (New Zealand). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the performance report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. Other than in our capacity as auditor and the provision of Non-Financial Assurance Services we have no relationship with or interests in the New Zealand Kennel Club Incorporated or any of its subsidiaries. These services have not impaired our independence as auditor of the Entity and Group.

Basis for Qualified Opinion

In common with other organisations of a similar nature, control over the revenues from gate sale donations prior to being banked is limited. It was not practicable to extend our examination of gate sale donations and fund raising activities beyond the accounting for amounts received as shown by the accounting records of the New Zealand Kennel Club Incorporated, or to determine the effect of the limited control.

Other Matter / Unaudited Information

Without further qualifying our opinion, we note that the performance report also includes the statement of service performance on page 16, which we have not audited.

1. STATEMENT OF ACCOUNTING POLICIES

Reporting Entity

The New Zealand Kennel Club Incorporated (the "Club") is a society incorporated under the Incorporated Societies Act 1908. These financial statements are for the group which comprises the Club, the New Zealand Kennel Gazette Limited registered under the Companies Act 1993, a wholly owned subsidiary of the Club and the New Zealand Kennel Club Museum Trust Incorporated (the "Museum Trust"), which the Club has control over.

Basis of Preparation

These financial statements are reported under Tier 3 of the PBE SFR (accruals for NFP) as expenditure is less than \$2 million per annum.

Measurement Base

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historic basis are followed by the Club. The accounts have been prepared on the assumption that the Club is a going concern.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied:

(a) Goods and Services Tax ("GST")

These financial statements have been prepared on a GST exclusive basis, except for accounts receivable and accounts payable, which are reported on a GST inclusive basis.

(b) Property, Plant and Equipment

Property, plant and equipment is recorded at historical cost, less depreciation and impairment.

(c) Depreciation

Depreciation has been calculated on a straight line basis at the following rates:

(d) Taxation

The Club is recognised as being a sporting body and as such is not liable for income tax under CW46 of the Income Tax Act 2007. The Club has a tax exemption certificate from Inland Revenue.

(e) Principles of Consolidation

- (i) These financial statements are for the group which comprise the Club, its wholly owned subsidiary the New Zealand Kennel Club Gazette Limited and the Museum Trust. The New Zealand Kennel Club Gazette Limited as a company does not trade and all activities associated with the Gazette are treated as a business unit of the Club. The Museum Trust has a term deposit as shown on Note 4, the interest of which is immaterial to the results of the group. As the subsidiaries are either non-trading or are immaterial to the group, the results of the parent have not been shown separately. The balance date of both subsidiaries is 31 March.
- (ii) The Statement of Financial Performance on page 4 eliminates all intra group transactions.

1. STATEMENT OF ACCOUNTING POLICIES (cont'd)

(f) Receivables

Debtors are stated at estimated realisable value.

(g) Revenue Recognition

Subscriptions and memberships are accounted for as earned with no adjustments for accounts received in advance or arrears. Other revenue including Affiliation Fees are accounted for on an accruals basis. Those Affiliation Fees received that are related to the next financial year are recorded as receipts in advance. Revenue from gate sales and fund raising activities is recognised as earned, as their receipt cannot be anticipated. There is no revenue outstanding at year end that was received on a use or return basis.

(h) Donations

Donations and other gratuities are recognised as revenue at the point when receipt is formally and officially acknowledged by the Club.

(i) Expense Reclassification

Expenses totalling \$14,702 in 2015, were previously reported as sub committee expenses, but have been reclassified under Other Expenses. General Consulting fees totalling \$2,267 have also been reclassified.

(j) Changes in Accounting Policies

There were no changes in accounting policies as a result of changing from reporting under GAAP to reporting under Tier 3.

(k) Operating Leases

Leases that do not transfer substantially all the risks and rewards incidental to ownership of an asset the entity are classified as operating leases. Lease payments under an operating lease are recognised as an expense on a straight line basis over the term of the lease in the statement of financial performance.

FAQ...

What were the main factors that produced a cash surplus of \$221k compared to a budget of \$128k, and compared to a surplus last year of \$157k?

Income was \$9k below budget, so the positive variances was from under expenditure.

The two main areas of substantial variance were NZKC (main) - \$65k and Auckland - \$25k. Auckland had budgeted to spend money on their facilities block, which didn't happen. In Wellington office there were savings in many areas but most noticeably in personnel.

Where has this cash surplus been invested?

A substantial portion of this surplus has been invested in improvements in our three properties. A total of \$137k was spent in the past year, (\$91k last year). In Dunedin we spent \$21k replacing the skylights. In Auckland a total of \$20k on a number of smaller improvements, but the largest expenditure was in Wellington with new turf in the side hall (\$22k), and all the lights were replaced with LED's, (\$48k). This was done to coincide with the National Dog Show. The lighting in Auckland had been similarly upgraded in the previous year.

Why was it necessary to write down the value of the fixed assets by \$376k.

Over the years there were two main areas where the fixed assets had been recorded incorrectly. Items that should have been fully depreciated were still recorded as having a substantial book value. Many of these items were older than 10 years, but items less than 10 years old had also been insufficiently depreciated.

The second main factor are a number of items that were recorded as assets, but should never have been. There were a number of larger value items that should have been charged to maintenance, such as the annual maintenance fee for the Wellington property, which runs to several thousand dollars a year. There were also a number of very low value items, even including an extension cord valued at \$15.60!

Does the write down affect the value of our properties?

The write down as no effect on the book value of our properties which are recorded at \$1.435m. That is land buildings and improvements. All three properties were revalued in March. The market value of Auckland is \$5m, Wellington \$3.2m and Dunedin has a value of \$683k for insurance purposes. The total value is \$8.9m.

Are there any areas of revenue that need to be highlighted?

The budget for registry revenue, which includes registration, export, import etc, was a stretch, and fell short of budget and less than 2015. Sponsorship included a grant of \$16k towards the replacement of the arena lighting in Wellington. The only other significant was revenue from the National Dog Show, with revenue \$26k ahead of budget as a result of marketing aimed at increased patronage.

Are there any areas of expense that need to be highlighted?

Personnel costs are a major item of expenditure and the budget included a full time Canine Health Officer from July 2015. As this was a new position personnel costs were ahead of the previous year, but as the appointment did not occur until November, there was a positive variance to budget.

Administration Costs. There are both savings and one off costs last year that have contributed to positive variances. Legal costs budgeted for Auckland did not occur, and there were some large legal costs in Wellington in the previous year. A new contract for the photocopier is saving in excess of \$15k per annum.

Property cost variances are the result of a conservative budget based on the previous year for Wellington, (\$10k). In Auckland underspend was \$24k, due to the spend on the facilities block being deferred.
